

**NOTICE OF PUBLIC HEARING
BY THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF
DECATUR TOWNSHIP, MARION COUNTY, INDIANA**

The citizens of the Metropolitan School District of Decatur Township, Marion County, Indiana (the "School Corporation"), are hereby notified that the Board of Education of the School Corporation (the "Board") proposes to pay for all or a portion of the costs incurred, or to be incurred, by the School Corporation in connection with the 2026-2030 District-Wide Long-Term Capital Maintenance and Equipment/Vehicle/Bus Acquisition Project, as defined and described in the resolution adopted by the Board on March 10, 2026 (the "2026-2030 District-Wide Long-Term Capital Maintenance and Equipment/Vehicle/Bus Acquisition Project"), with the proceeds of general obligation bonds to be issued by the School Corporation in one or more series or issues, to be designated as the "Metropolitan School District of Decatur Township, Marion County, Indiana, General Obligation Bonds, Series 20__ (such designation to be the year issued and other distinguishing characteristics as necessary" (collectively, the "2026-2030 General Obligation Bonds"). A portion of the proceeds of the 2026-2030 General Obligation Bonds will also be used to pay for all or a portion of the costs and expenses incurred in connection with or on account of the issuance of the 2026-2030 General Obligation Bonds. The 2026-2030 General Obligation Bonds will be issued in an aggregate original principal amount not to exceed \$20,605,000 (less the principal amount of any first mortgage bonds issued by the Decatur Township Multi-School Building Corporation to fund a portion of the costs of the 2026-2030 District-Wide Long-Term Capital Maintenance and Equipment/Vehicle/Bus Acquisition Project), have a final maturity date of no later than twenty (20) years from the date the 2026-2030 General Obligation Bonds are issued, and bear interest at a maximum rate or rates not to exceed 7.00% to be determined by negotiation.

Notice is hereby given by the undersigned that the Board will, on July 14, 2026, at 7:00 p.m. (local time), in the Board Room of the Administration Building of the School Corporation, located at 5275 Kentucky Avenue, Indianapolis, Indiana, conduct a public hearing regarding the matter of appropriating the proceeds of the 2026-2030 General Obligation Bonds and investment earnings thereon. All interested parties are entitled and encouraged to attend to present their testimony and ask any questions relative to the 2026-2030 District-Wide Long-Term Capital Maintenance and Equipment/Vehicle/Bus Acquisition Project or the 2026-2030 General Obligation Bonds.

Subsequent to the public hearing, the Board expects to consider adoption of a resolution regarding the appropriating of the proceeds of the 2026-2030 General Obligation Bonds and the investment earnings thereon for the purposes described herein.
